Feb 2, 2026** Semi-Annual	7/1/25 – 12/31/25	<u>460</u>	 All committees must file this statement unless the committee filed termination forms 410 and 460 before December 31, 2025. Period covered is 10/1/25 – 12/31/25 if an odd-year report was filed.

- **Deadline Extensions: Deadlines are extended when they fall on a Saturday, Sunday, or an official state holiday. This extension does not apply to a 24-hour/10-day Contribution Report (Form 497) that is due the weekend before the election, and this extension never applies to any 24-hour/10-day Independent Expenditure Report (Form 496). Such reports must be filed within 24 hours, regardless of the day of the week.
- Where to File: State committees file statements with the Secretary of State. Only candidate-controlled committees that are <u>not</u> E-Filers file paper copies with the elections official at the candidate's county of domicile.
- <u>Form 501</u>: All state candidates must file Form 501 before soliciting or receiving any contributions or before making expenditures from personal funds. A candidate may, until the deadline for filing nomination papers set forth in Section 8020 of the Elections Code, amend Form 501 to change their statement of acceptance or rejection of voluntary expenditure limits, provided they have not exceeded the limits.
- Form 460: All state committees, including E-Filers, must also file paper statements.
- Paper Filings: All paper filings may be filed by first-class mail or by email with a verified digital signature unless otherwise noted. Persons required to file a report or statement by paper with the Secretary of State's Office may instead file by email (digitalfiling@sos.ca.gov) with a verified digital signature or other digital means as prescribed by the Secretary of State's Office. Please visit the Secretary of State's website for more information on how to file with a digital signature.
- E-Filer: A state committee that has received contributions or made expenditures totaling \$25,000 or more.
- Forms 496 and 497: All reports are filed online only.
- State Contribution Limits: Refer to the contribution limits chart on the FPPC website.
- **State Special Elections**: If a state special election is held in 2025, a filing schedule will be posted on the FPPC website. Additional statements may be required. Form 497 is required if contributions totaling \$1,000 or more in the aggregate are made to a state or county political party committee during the 90 days prior to a state election, or on the date of the election, including a state special election. Please see the applicable state special election filing schedules for additional information and filing deadlines.
- Expenditures for Local Elections: 24-hour independent expenditure or contribution reports (Forms 496 or 497) must be filed if independent expenditures or contributions totaling \$1,000 or more are made during the 90 days before an election or on the date of the election. Independent expenditures of \$1,000 or more also require the filing of Form 462. Contact local jurisdictions for information on local restrictions (e.g., contribution limits), if any.
- **Penalties:** Late statements are subject to a fine of \$10 per day on both the paper and the e-filed version (i.e., \$20 per day for a late e-filed Form 460). Failure to file a statement could result in an enforcement penalty of \$5,000 per violation.
- Public Documents: All statements are public documents.

Committees Primarily Formed to Support/Oppose Candidates for State Office:

- Multi-Purpose Organizations (including non-profits): A multi-purpose organization that uses its general dues account to make contributions or expenditures
 may qualify as a major donor or independent expenditure committee and may be required to report payments on Campaign Form 461. Such an organization will
 qualify as a recipient committee if expenditures exceed \$50,000 in a 12-month period or \$100,000 in four consecutive calendar years. An organization that
 qualifies as a recipient committee may need to file reports disclosing contributors. See the Campaign Reporting Rules for Multipurpose Organizations fact sheet.
- Form T-10: Committees primarily formed to support or oppose a state candidate that receive contributions totaling \$1 million or more must file this report with the FPPC within three business days.
